MOTION TO DISMISS FOR VIOLATION OF DEFENDANT'S DUE PROCESS
RIGHTS AND PROSECUTORIAL MISCONDUCT

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW, Joey Sula, Defendant, in the above styled and numbered cause and requests this Honorable Court to dismiss said cause for denial of Defendant's rights of due process under the Texas and United States Constitutions and in support thereof shows the Court as follows:

I.

Joey Sula stands charged by indictment with the offenses of theft and money laundering. These charges were instigated by Assistant District Attorney, Mike Elliott.

A true copy of Fort Bend County Criminal Docket---Thursday, May 22, 2008 reflecting Mike Elliott as the Assistant District Attorney in charge of the case is attached as Exhibit 1 and incorporated by reference the same as if fully copied and set forth at length.

II.

Assistant District Attorney Mike Elliott has several personal and professional connections with the Complainant. Karen Pearson served as the Republican political consultant for Mike Elliott's wife, Annie Elliott, as candidate for office. Annie Elliott is currently the District Clerk of Fort Bend County, Texas. Mrs. Elliott was elected to her office in November, 2006, some three months before Mike Elliott began his campaign to

AUG 4 & 2000 DISTRICT ATTORNEY'S OFFICE collect the money Joey Sula owed Karen Pearson. Mike and Annie Elliott have a close personal relationship with Karen Pearson. After the election of Annie Elliott, the two couples, Karen Pearson with Joey Sula and the Elliotts socialized together. In fact, Joey Sula was asked by Karen Pearson to assist Annie Elliott in obtaining a bond to meet the requirements of her office shortly before she took the oath of office.

III.

On or about February 15, 3007, Mike Elliott contacted Joey Sula as Karen Pearson's civil attorney regarding the repayment of the money back to Karen Pearson. No agreement could be reached between the parties and the matter remained unresolved for several months.

IV.

On May 24, 2007, Mike Elliott acquired the services of several deputies from the Fort Bend County Sheriff's office and an investigator for the Fort Bend County District Attorney's office, Sean Costello and, traveling from Fort Bend County to Harris County, deprived Joey Sula of his freedom outside a night club named "Mo's Place". In the parking lot at Mo's Place, officers of Fort Bend County Sheriff's Department and Fort Bend County District Attorney's office took Joey Sula into custody at gun point by hand cuffing him and placing him in an automobile assigned to Fort Bend County District Attorney's office.

V.

At that time, while Joey Sula was restrained of his liberty in the parking lot located in Harris County, Texas for more than two hours, Fort Bend County District Attorney Investigator Sean Costello threatened Defendant with criminal prosecution if

the loan to Karen Pearson was not immediately repaid. At all times during this episode, Assistant District Attorney Mike Elliott presided over the entire episode by standing outside the automobile in clear view of Joey Sula.

VI.

The District Attorney's office was provided copies of emails from Karen Pearson to the Defendant wherein Ms. Pearson referred to the loans as loans. True and correct copies of emails wherein Karen Pearson consistently refers to the transactions between her and the Defendant as "loans" are attached as Exhibit 2 and incorporated by reference the same as if fully copied and set forth at length. When it became apparent that Mike Elliott would use the assets of Fort Bend County to harass Defendant with criminal process, Joey Sula retained an attorney to communicate with the District Attorney's office and to arrange for his appearance before the Fort Bend County Grand Jury. Through the efforts of Mike Elliott, Defendant was denied an opportunity to appear before them.

VII.

Mike Elliott was the lead prosecutor on the cases against Joey Sula. A true and correct copy of the FortBendCountyGov website dated January 24, 2008 reflecting Mike Elliott as "prosecutor" on Cause Number 48259 wherein Joey Sula is defendant is attached as Exhibit 3 and incorporated by reference the same as if fully copied and set forth at length. Although one indictment was dismissed, Mike Elliott remained as prosecutor on the instant case against Defendant.

VIII.

The Texas Code of Criminal Procedure, Article 2.01 states that it is the duty "of all prosecuting attorneys not to convict, but to see that justice is done." The Texas Disciplinary Rules of Professional Conduct proscribe the conduct of a District Attorney as a lawyer from presenting, participating or threatening to present criminal charges solely to gain an advantage in a civil matter. Rule 4.04, Texas Disciplinary Rules of Professional Conduct.

IX.

The duty to avoid a conflict of interest has long been imposed on the prosecutors of the State; see State Ex Rel. Sherrod v. Carey 790 SW2d 705 (Tex. App. Amarillo. 1990); State v. May 270 SW2d 682 (Tex. Civ.App. 1954); Worthington v. State 714 SW2d 461 (Tex.App. Houston 1st Dist., 1996). The clear implication of and Worthington is that Article 2.01 must be constructed broadly enough to protect a defendant from conflicts of interest involving not only the elected district attorney himself but also members of his staff The district attorney and his entire office, under appropriate circumstances, may be disqualified from participation in a particular case on constitutional grounds as well as under Disciplinary Rules of Professional Conduct. The Trial Court has a duty to protect a defendant's rights to due process of law under both the Texas and the United States Constitutions, see Ex Rel. Sherrod v. Carey supra. Certainly, a prosecutor's violation of ethical rules will subject a case to reversal when his unprofessional conduct results in a denial of due process to a Defendant. "Removing a district attorney's office from a particular case however, is clearly distinct from an attempt to remove an official from his or her elected office." Courts also have taken strong views on the "appearance of impropriety to the general public. In State v. Ex Rel. Eidson v. Edwards, 793 SW2d I

(Tex.Crim.App.1990) and <u>Re Corrugated Container Antitrust Litigation</u>, 659 F2d 1341 (5th Cir, 1981), both cases dealt with the appearance of impropriety.

X.

Lawyers owe a duty of scrupulous honesty, forthrightness and the highest degree of ethical conduct and inherent in these duties is compliance with both the spirit and the express terms of established rules of conduct and procedure; see J.B.K. 931 SW2d 581 (Tex. App. El Paso 1996). The cannons do not depend upon which side of the bar the lawyers sits, prosecutors are not immune from the cannons of professional conduct; State v. Ex Rel. Eidson v. Edwards, 793 SW2d 1 (Tex. Crim. App. 1990). A Trial Court can only disqualify a district attorney or his staff on the basis of a conflict of interest if the conflict rises to the level of a due process violation, see State Ex Rd. Hill v. Pirtle, 887 SW2d 921 (Tex. Crim. App.). In fact, a district judge must comply with the Code of Judicial Conduct which requires that he take or initiate appropriate disciplinary measures against a lawyer for unprofessional conduct of which judges become aware, see State Ex Rel. Hill supra. Rule 4.04, specifically applies to the prosecutor who participates in a criminal action when the result is to gain advantage in a civil matter, see State Er Rel. Hill supra. In Young v. US Ex Rel Vuitton Et. Filssa, 481 US 787 107 S.Ct. 2124, 952.ed. 740 (1987), the Supreme Court held, "we may require a stronger showing for a prosecutor than a judge in order to conclude that a conflict of interest exists. Once we have drawn that conclusion, however, we have deemed the prosecutor subject to influences that undermine confidence that a prosecution can be conducted in a disinterested fashion. If this is the case, we cannot have confidence in a proceeding in which these offices plays the critical role of "preparing and presenting" the case for the defendant's guilt," id. 481

US at 804-811, 107 S.Ct. at 2136-2138, see also Ethics Opinion 332 (August 1967). Conflicting Interests — Public Prosecutor Representing Civil Suitors: it is improper for a public prosecutor to represent any party in a civil matter arising out of an occurrence which also is the subject of a criminal "investigation" or prosecution, within the jurisdiction of such public prosecutor. Rule 4.04(b) Texas Disciplinary Rules of Professional Conduct and accompanying comment to the rule expresses concerns about using the criminal process to coerce a party in a private matter which improperly suggests that the criminal process can be manipulated; see <u>State Ex Rel. Hill v. Firtle supra.</u>

XI.

Although John Healey, elected District Attorney of Fort Bend County, Texas has removed Mike Elliott as the lead attorney in this case, the taint of his prosecutorial misconduct and his conflict of interest colors the ability, impartiality and fairness for the District Attorney's Office of Fort Bend County to question and investigate a fellow member with his rank in the office. Mike Elliott's abuse of the power of the District Attorney's office as well as his retention of the Fort Bend County Sheriff's office in the unlawful detention of the Defendant--in another county and without jurisdiction to so act-have violated the due process rights of Joey Sula under the Texas And United States Constitutions.

XII.

Mike Elliott's conflicts of interest and his personal, political and monetary interests have tainted the fairness and impartiality of this proceeding. The commingling of criminal and civil investigations effectively denies the Defendant a right to a fair and adversarial proceeding. By oppressing the Joey Sula's opportunity to appear before the

Grand Jury, Mike Elliott gained partisan advantage for his political ally. Such abuse of power coupled with tainted investigations and grand jury process suppression have fundamentally denied Defendant, Joey Sula his rights under the due process clause of the Texas and the United States Constitution.

WHEREFORE, PREMISES CONSIDERED, the Defendant respectfully prays that this Honorable Court will conduct a hearing and then dismiss with prejudice the said cause of action.
